Prospective bidders should have experience in undertaking a similar project within the last three (3) years with an amount at least 50% of the proposed project for bidding have key personnel and equipment (owned, leased/under purchase) available for execution of the project. The Eligibility Check and Preliminary Examination of Bids shall use nondiscretionary "pass/fail" criteria and subject to post-qualification of eligible bidders.

All particulars relative to Eligibility, Bid Security, Performance Security, Pre-bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. No. 9184 and its Revised Implementing Rules and Regulations (RIRR).

Bid Documents will be available starting **10th January 2011** from **9:00 a.m. to 4:00 p.m.** at the LGU Jagna BAC Secretariat, MPDC Office upon payment of a non refundable amount of P 500.00.

BAC will conduct its **Eligibility & Technical Component Check and Opening of Bids Proposal** to all interested bidders on **Tuesday, 18 January 2011 at 10:00 a.m.** Capt. Goyo Casenas Hall, Municipality of Jagna, Jagna, Bohol.

Bids will be opened in the presence of the bidders or their representatives who choose to attend. All bids must be accompanied by a Bid Security amounting 1% of Approved Budget Contract. Late bids shall not be accepted.
